1.0 BACKGROUND

1.1 About REIL:

Rajasthan Electronics & Instruments Limited (REIL) is a rapidly growing “Mini Ratna” Central Public Sector Enterprise under the administrative control of Department of Heavy Industry, Ministry of Heavy Industries and Public Enterprises, Government of India; with the aim to undertake manufacturing and development of professional grade electronic equipments and solutions in the area of Dairy, Renewable Energy and IT solutions.

REIL is a professionally managed Company with sound track record. Its products are deployed in more than 1 Lac villages and cities all over the country having deployment of 45 MWp and over 365,000 nos. of solutions.

The Company is jointly promoted by the Government of India (51% share) and Government of Rajasthan (49% share through RIICO, Jaipur).

The USP of the Company lies in providing onsite service to rural/urban users through a network of 8 Regional Offices, 17 FMCs (Field Maintenance Centre) and 81 Sub-FMCs.

2.0 SCOPE OF WORK FOR TRANSPORTERS.

Detail scope of work or subsequent terms and conditions for the transportation of material will be as per the requirements of project, however broad scope of work is as follows:

1. Transport the material from REIL Jaipur to desired location across the India.
2. Required labour for loading and unloading of material.
3. Receipt of material in desired format from the consignee /concern authority.
4. Arrangement of required necessary document to transport the material up to destinations.
5. This invitation for proposals is open to all companies / partnership / proprietary firm, etc. operating within India and who are eligible to do business of transportation in India under relevant Indian / State laws, as applicable.
6. This EOI document is neither an offer letter nor a legal contract, but an invitation for expression of interest only.
7. No contractual obligation on behalf of the Bank whatsoever shall arise from this EOI.
8. EOI for empanelment will be treated under process unless and until a list of successful transport contractors is published on the company website.
9. The REIL will not be liable for any expense/cost incurred by the contractors in the preparation of the response to this EOI. The consideration of the transport contractor's proposal does not cast any obligation on the part of the REIL to avail his services, and the REIL is not bound to discuss reasons for acceptance or rejection of the contractor's proposal.
10. All information included by the transport contractors in their proposal will be treated in strict confidence.

Important Notes:

1. Empanelled transporters through this EOI shall be eligible to participate in separate BIDS subsequently invited on GEM portal for transportation of goods/material across the country.

3.0 EMPANELMENT PROCESS

3.1 SUBMISSION OF E.O.I.:

1. Rajasthan Electronics and Instruments Limited, a public sector undertaking, joint venture of Government of India and Government of Rajasthan ("REIL" or the "Company"). REIL plans to empanel reputed transporter / Contractors for transportation of material, Vehicles of desired specifications on as and when required basis across the country. Eligible transporters are advised to read this document in detail and assess their capabilities before submission of Expression of Interest.
2. This Invitation has been prepared to enable potentially interested Firms who are meeting the qualification criteria to submit their Expression of Interest ("EOI").
3. All the transporter meeting the eligibility criteria defined under this Eol shall be short-listed.
4. Company will decide to empanel/rejection of transport contractors. The decision of the evaluation committee on technical suitability shall be final & binding.
5. Interested agencies may download the transporter registration form & Eol document from the website of the company **www.reiljp.com**. The prospective agencies desirous of participating may view and download the document free of cost from the website of REIL. However transporter need to submit the document fee of Rs. 2500/- (Rupees Two Thousand Five Hundred only) through Cash/DD/NEFT/RTGS, and submit its copy along with the response. The proposals received without the Eol document fees will result in rejection of the proposal.
6. Interested agencies may submit their Expression of Interest (Eol) by providing all the necessary documents in English as specified in this document for each of the qualifying criteria as proof of meeting the Eligibility criteria.

9. REIL reserves the right to withdraw this EoI or reject the whole/part of any/all bids received, without assigning any reasons.
10. During evaluation of submitted EOI, REIL may ask for any other technical & financial documents from the party.
11. During evaluation of the EOI, REIL shall call the parties for a presentation. Party has to explain the execution methodology in the presentation.
12. After completion of evaluation process, REIL shall issue empanelment list of empanelled parties on REIL website.

3.2 EoI Document fee

1. The EoI document fee is Rs. 2500/- + 18% GST (Rs. Two Thousand Five Hundred only plus eighteen percent GST) and is required to be submitted through Cash/DD/NEFT/RTGS before the last date of receipt of response as mentioned in this document.

3.3 Eligibility Criteria

The participation in the EoI is invited from reputed parties/Enterprises who meet all the following criteria.

1. The Transport Contractors should be a company registered under the Indian Companies Act, 1956 or Companies Act, 2013
Or
The Transport Contractor should be a company/ firm/ LLP / proprietorship.
2. Minimum three years of experience in the field of transportation across the country.
3. Transportation network across PAN india.
4. Minimum average annual turnover of Rs. 2.5 Cr. during the last three financial years supported by audited financial statements.
5. The Net Worth shall be positive and based on audited annual accounts of the company as on 31st March 2023.
6. The Transport Contractor should have a valid PAN no. & GST no.
7. Necessary self vehicles, associate vehicles and Godawns to complete the works assigned, with documentary evidence for the same to be submitted along with this EOI.
8. List of PSU/other reputed clients be submitted with EoI with required documents.
9. If the Transport company registered in MSME declaration/certificate be attached.

3.4 NO NEAR RELATIVE CLAUSE

The bidder should give a certificate that none of his/her near relative is working in REIL as defined below along with their technical bid as per the attached Annexure . In case of proprietorship firm certificate will be given by the proprietor. For partnership firm certificate will be given by all the partners and in case of limited company by all the Directors of the company excluding Government of India/Financial institution nominees and independent non-Official part time Directors appointed by Govt. of India or the Governor of the state and full time Directors of PSUs both state and central. Due to any breach of these conditions by the company or firm or any other person the tender will be cancelled and Bid Security will be forfeited at any stage whenever it is noticed and REIL will not pay any damage to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in REIL's tender. The near relatives for this purpose are defined as:- (a) Members of a Hindu undivided family. (b) They are husband and wife. (c) The one is related to the other in the manner as father, mother, son(s) & Son's wife (daughter in law), Daughter(s) and daughter's husband (son in law), brother(s) and brother's wife, sister(s) and sister's husband (brother in law).

3.5 Instructions :

1. The bidder shall bear all the costs for participation in the bid process including preparation of responses to the EOI and must be ready to undertake this activity on its own.
2. The transporter should not have been blacklisted by any ministry from any country, Government department or customer of the Central of state Government of the country. This undertaking becomes the part of the Cover-note.
3. Any false information provided in the EOI with respect to citations, Projects handled or any other information – if found out incorrect by REIL, would lead to disqualification of the transporter and other suitable penal actions.
4. This EOI does not constitute and will not be deemed to constitute any commitment on part of REIL For any purchase/work order.

3.6 EXCLUSIVITY:

During the validity period of this EOI, unless with the previous written consent of the other Party to the contrary, the Parties shall not enter into any similar agreement/ Memorandum of Understanding of any nature in respect of the Project and/ or discuss matters concerned under this Agreement, either directly or indirectly or through its subsidiary/ associate or otherwise with any other party (ies).

3.7 Disqualification

1. REIL shall not consider for the purpose of qualification, an EOI, which is found to be incomplete in content and/ or attachments and/ or authentication, etc.
2. Without prejudice, a sole Firm or a consortium may be disqualified and its EOI dropped from further consideration for, but not limited to, any of the reasons listed below:
 - Misrepresentation by the potential Firm or any member of the consortium during or after the EOI process; (or)
 - Failure by the parties mentioned above to provide necessary and sufficient information required to be provided in the EOI; (or)
 - Where a party has already submitted an EOI as sole interested Firm and such party submits another EOI as a member of a consortium; (or)
 - Where a party has already submitted an EOI as a member of a consortium and such party submits another EOI either as a sole interested Firm or a member of another consortium. (or)
 - Parties convicted by a Court of law; (or)
 - Parties against whom any adverse order has been passed by a regulatory authority that casts a doubt on the ability of the party to manage large works.

GENERAL TERMS & CONDITIONS OF THE CONTRACT

1) AMENDMENT

Except as otherwise provided herein, no addition, amendment to or modification of the EOI shall be effective unless it is in writing and signed by and on behalf of both parties.

2) SEVERABILITY

In the event that any or any part of the terms conditions or provisions contained in the EoI shall be determined invalid, unlawful or unenforceable to any extent such term, condition or provision shall be severed from the remaining terms, conditions and provisions that shall continue to be valid and enforceable to the fullest extent permitted by law.

3) CONFIDENTIAL TREATMENT

It is understood and agreed that data, know-how and other such proprietary information that was provided or will be provided by either party, will remain confidential.

4) RELATIONSHIP OF THE PARTIES

Transporters relationship with REIL will be that of a Transport Contractor, and nothing in this Contract shall be construed to create a relationship, joint venture, partnership.

5) INDEMNITY

REIL and the Transport Contractor shall indemnify, defend, and hold harmless each other and its divisions, successors, subsidiaries and affiliates, the assigned of each and their directors, officers, agents and employees from and against all liabilities, claims, losses, and damages of any nature, including, without limitation, all expenses (including attorney's fees), cost, and judgments incident there to REIL and REIL's obligations under this indemnity will survive the expiration, termination, completion or cancellation of this Contract or an order hereunder.

6) FORCE MAJURE

REIL and the Transport Contractor shall not be under any liability to each other or to any other party in any way whatsoever for the destruction, damage, delay or any other matters of the nature arising out of reasons beyond the control of either party, including but not limited to a war, rebellion, civil commotion, strikes, lock-outs and industrial disputes; fire, explosion, earthquake, Act of God, flood, drought, bad weather, requisitioning or other act or order by any government department, council or other constituted body, and similar other reasons.

7) RESTRICTION ON EMPLOYMENT

Both the parties have agreed that they will not recruit any members of staff of other party directly or indirectly.

8) ARBITRATION

All disputes arising out of this contract and questions relating to its interpretation etc. shall be referred to the EoI committee headed by ED/GM and if not resolved shall be referred to the sole arbitration of Managing Director, Rajasthan Electronics & Instruments Ltd., for his decision, which shall be final and binding on both parties. The Venue of Arbitration proceedings shall be at Jaipur.

9) RISK AND COST

In the event of failure on the part of the Transporter , REIL shall be entitled to cancel the empanelment order and transport at risk and costs of the Transporter.

10) GOVERNING LAW

This contract and its validity, interpretation and performance will take effect and be governed under the laws of India. Venue in any action in law or equity arising from the terms and conditions of this contract shall be the court of appropriate jurisdiction in Jaipur, Rajasthan (India)

11) OTHER TERMS & CONDITIONS:

Compliance with Regulations and Indian Standard:- All works shall be carried out in accordance with relevant regulations, both statutory & those specified by the Indian standard related to the works covered by this specification. In particular the equipment and installation will comply with the following:-

- a. Work man's compensation act.
 - b. Minimum wages Act.
 - c. Payment wages Act.
 - d. Contact Labour regulation & abolition Act.
 - e. ESI, PF & Bonus Act.
 - f. Regulation under Indian Electricity Rules,
 - g. Safety & electrical Standard as applicable
 - i Watch & Ward:-
- Empanelled Transporter shall arrange for compliance with statutory provision of safety regulation and departmental requirements of safety codes in respect of labour employed on the work by the Vendor. Failure to provide such safety requirements would make the Vendor liable for penalty. The department will make arrangement for the safety requirements at the cost of the Vendor & recover the cost thereof from him.
 - Company shall not be held liable or responsible for any illness and for physical harm sustained by the Empanelled transporter authorized representative during the execution of this agreement as they will not be deemed in any manner as employee of the company.
 - Correction, over-writing and alteration should be initialed and dated by the Transporter otherwise the bid is liable to be rejected. The bid shall be typed or written in ink. Unit rates should be mentioned in the specified format failing which the bids are not likely to be considered.
 - All Transporters shall therefore, furnish declaration that their firm is not involved in any litigation that may have an impact of affecting or compromising the delivery of services as required under this assignment. It is also to be declared that their firm has not been black listed by any Central/State/ Public Sector Under takings in India. The declaration should be verified by the Notary Public.
 - The Transporters shall sign these conditions on each page at the end in token of acceptance of all the terms and it would be attached with the bid along with the declaration mentioned in above. He should also sign at the bottom of each of the pages of his bid to be submitted.
 - The company shall be fully absolved from the third party claims and damages during the execution of the contract.
 - In the event of any break-down, servicing and repairs of vehicles, transporter at his own cost shall make alternate arrangement by providing similar class of vehicle. Failure to do so will evoke penalty.
 - The REIL will in no way be responsible for violation of traffic rules and /or infringement of any other law for the time being in force, either by the driver of the vehicle or by the transporter.

Signature and Stamp of Transporter

The driver as well as transporter shall comply with relevant rules and regulations of Motor Vehicles Act and Rules applicable at present and as may be enforced from time to time for which user departments would not be liable/responsible in any manner whatsoever. Onus of compliance of all the applicable Laws/Acts/Rules including those under Motor Vehicle Acts/Rules shall rest with the transporter only and user/user departments will not be liable in any manner.

- In case the transport company does not deliver the products within the period stipulated, the transport company will be liable to pay damages and the same shall be recovered from the bills of the transport company.
- In case of accident/loss/theft during transit, Transporter shall register FIR at nearest police station at earliest and report the case to REIL within 48 hours writing or through email for insurance claim purpose.
- In case of accident the transporter is obliged to submit the required documents in time. The failure to do this shall be treated as a fault that is attributable to transporter. The documents include:
 - Certificate of facts (COF)
 - LR/GR copy duly acknowledged (With remarks if any)
 - Any other documents as required by insurance agency.
