LARGEST NATIONAL OFF-GRID ROOF-TOP POWER PROJECT AT 9348 LOCATIONS



Bharat Nirman Rajeev Gandhi Seva Kendra (BNRGSK)

REIL has successfully executed the largest national off-grid roof-top solar power-pack project of 10 MW, by installing 2.24 KWp capacity power pack at 248 Panchayat Samiti and 1.12 KWp capacity power pack at 9100 Gram Panchayat, spread in an area of 3.42 Lac sq. km. across the state of Rajasthan.

These power packs are being used to power computer systems at the Bharat Nirman Rajiv Gandhi Sewa Kendra (BNRGSK), established

by the Rural Development & Panchayat Raj Department, Government of Rajasthan under Jawarlal Nehru National Solar Mission (JNNSM). The Ministry of New and Renewable Energy (MNRE), Government of India, has also extended support to the project, including central financial assistance.

The System Configuration

There are two system configurations namely 2.24 KWp for Panchayat Samiti and 1.12 KWp for the Gram Panchayat.

The 2.24 KWp power plant comprises 2240 watt capacity Crystalline Silicon SPV modules; 4 KVA DSP sine wave inverter (96V) input/230V single phase output; Solid State **PWM charger** with 96 V DC input and **adequate protection**; Tubular positive plate battery bank 96V, 300AH; junction boxes,

wires, cables, tags etc. The above configuration supplies power to operate 10 Computer systems and network equipment over 6 hours and a printer for 1 hour.

Similarly the 1.12 KWp power plant comprises 1120 watt capacity SPV Crystalline Silicon modules; 2 KVA DSP sine wave Inverter (48V) input/230V single phase output; Solid State PWM charger with 48 V DC input and adequate protection; Tubular positive plate battery bank 48V,





300AH; junction boxes and wires, cables, tags etc. The above configuration supplied power to operate 5 Computer systems and network equipment over 6 hours and a printer for 1 hour.

The mounting structures are galvanized to avoid corrosion, and have anti-theft feature. These Solar PV hybrid systems have facility for charging through SPV and AC mains.

The scope of the project was to commission systems at over 9348 locations across Rajasthan. As the success of the project depended on timely completion of preceding activities, monitoring them was a challenge for the stakeholders, government agencies and vendors, and significant for REIL to execute its contractual obligations.

To handle the challenge, an out of the box ICT initiative www.reilsolar.com - was conceived, design and developed. The solution emerged as a Project Management tool, which monitors the multiple activities









right from construction of building to commissioning and complaint handling. This has speeded up the entire process as it keeps track of various status levels of building construction viz. Plinth Level, Lintel Level, Roof Level, Under-Finishing, completion of building, site readiness etc. to facilitate planning of schedules for production, dispatches, installation; and hand-over of sites in a timely manner. This has helped the government to keep track of the readiness of the Kendras across the state.

The user interface provided on the website helps the users to: obtain information about the system to increase awareness; get information on vendor's scope and responsibility; become sufficiently knowledgeable on the use and performance of system and its sub-systems; log complaints as soon as problem is detected; and track the complaint status.

The beneficial experiences have led the website to be upgraded for use in tracking the commissioning of infrastructure and services at the BNRGSK, such as digital communication from BSNL, Gyan Kendra of RKCL, e-Mitra, Mini Bank etc.. The government uses the status to pursue the respective vendor/agency to accelerate the work; and the citizens can update on the services/facilities made available at the BNRGSK nearest to them. This website can also be used to track the implementation of any new service in future.

PERFORMANCE: Q1 FY 2013-14

In the first quarter of the year 2013-14, the Company has recorded a turnover of Rs. 20.92 Crore. The Renewable Energy Division and Electronics Division achieved first-quarter turnover of Rs. 8.67 Crore and Rs. 12.25 Crore respectively.

Achievements: Electronics Division

During this quarter, the Company received major orders for AMCU, from Andhra Pradesh, Bihar, Punjab, Rajasthan etc. and Milk Analyzer from Punjab, Tamil Nadu and Gujarat. The Company has also received orders for Electronic Milk Tester from Andhra Pradesh, Gujarat, Karnataka, Maharashtra, Punjab and Tamil Nadu.

During this quarter the Division has supplied sizable number of various Milk testing and collection units i.e Electronic Milk Testers, DPMCU, Smart-DPMCU, AMCU etc.

Achievements: Renewable Energy Division

During this period, the Division has supplied, installed and commissioned a 10 KWp SPV Solar Power Plant and Street Lighting Systems at Women Engineering College, Ajmer. The Company has also successfully installed solar water pumps in Rajasthan, under Horticulture Subsidy Scheme.

During the quarter, the Division has received a prestigious order from Indian Army for supply, installation and commissioning of seven numbers of 100 KWp SPV Power Plants in North Eastern states.

The Company had kept its promise to contribute in development of the state and received work orders for supply, installation and commissioning of sizable numbers of 50 and 30 KWp rooftop SPV systems. The Division has also received orders from various watershed departments for supply, installation and commissioning of SPV Street Lighting Systems.
