Business Highlights

Dairy Electronics

REIL's strategic & profound approach for upliftment of rural areas has strengthened the farmers economically while helping them ease their work by use of technology. During the quarter, various orders have been received for 600 DPUs from various milk societies of Rajasthan to bring accuracy and transparency; over 300 Ultrasonic Milk Analyzers from Arunachal Pradesh, Gujarat, Kerala, Rajasthan and Tamilnadu to provide one stop solution to determine the quality of milk delivered by dairy farmers and hence ensuring fair payment to them; orders for over 200 Electronic Milk Testers (EMTs) from various milk societies across the country and for over 70 Automatic Milk Collection Unit (AMCUs) from milk unions of Rajasthan, North Region and Central Region.

Digitization-other initiatives

Providing online solutions for its products/projects is another vital area of REIL, wherein it's IT division has done digitization of over 6 Lakh pages for Rajasthan State Open School and processed result of about 138824 students; provided the services as state level agency to Election Department, Rajasthan and successfully executed the generation of Electoral Roll for Lok Sabha General Election 2019 for 25 Assembly Constituencies.

The IT cell also revamped and hosted the existing website of Election Department Rajasthan (www.ceorajasthan.nic.in), in compliance to the Hon'ble Supreme Court directions for Accessibility on Departmental Websites/Portals for Persons with Disabilities (PWO).

Customer Training Program

A Total of 1903 numbers milk society secretaries and regional workers have been imparted training for operation of milk analyzers that has benefited more than 900 villages across PAN India.

Renewable Energy

After successfully addressing the electricity needs of un-electrified households under SAUBHAGYA scheme in Arunachal Pradesh, the Company has lighted over 6500 houses by deployment of 200W SPV based LED Home Lighting systems in remotest villages and Dhanis in Churu, Shri Ganganagar, Hanumangarh and Udaipur districts of Rajasthan providing last mile electricity connectivity to the households.

Under Atal Jyoti Yojna (AJAY), Phase-II, a flagship project of Government of India, over 1200 Street Lighting Systems have been installed in Madhya Pradesh, Uttarakhand and Rajasthan covering major roads, markets, and public conveniences in remote areas

to sustainably enhance the citizens' quality of life.

Under Networking of PUC centers, 7.77 Lakh pollution certificates have been generated during the quarter taking total generation to 53.33 lakh while in its role as PMC & AMC for Energy efficient LED lighting, REIL is maintaining 3.55 Lakh LED lights under Street Light National Program (SLNP).
